

TOWNSHIP OF SPRINGFIELD

ORDINANCE NO. 1552

AN ORDINANCE of Springfield Township, Delaware County and the Commonwealth of Pennsylvania, fixing the rate for the year 2015.

BE IT ORDAINED AND ENACTED, and is hereby ordained and enacted by the Commissioners of Springfield Township, County of Delaware, Pennsylvania.

SECTION 1.

That a tax be and the same is hereby levied on all property and occupations within the said municipality subject to taxation for the fiscal year 2015 as follows:

DISCOUNTS – PENALTIES

All taxpayers subject to the payment of taxes shall be entitled to a discount of two percentum from the amount of such tax upon making payment of the whole amounts thereof within two months after the date of the tax notice. All taxpayers who shall fail to make payment of any such taxes charged them for four months after the date of the tax notice, shall be charged a penalty of ten percentum which penalty shall be added to the taxes by the Tax Collector and be collected by her.
